What is Associated Pain Specialists self pay program?

Many Top level anesthesiologist owned interventional pain management facilities do not accept self pay patients making it difficult for that segment of the community to find quality pain mgt care. Associated Pain Specialists will make a limited number of self pay referral appointments available. Self pay referral appointments are only available to those patients that DO NOT HAVE INSURANCE OR THEY HAVE AN INSURANCE THAT APS DOES NOT ACCEPT.

What patients qualify for self pay?

- Patients without insurance
- Patients that have an insurance that APS does not accept

Patients that have an APS approved insurance will be scheduled as a regular pain management referral

What steps are required to become a self pay patient?

- Medical records and radiology reports must be received prior to patient appointment.
- Pre-visit interview with our patient care coordinator.
 - Rules, expectations, and guidelines of receiving self pay treatment will be discussed the day of their appointment prior to seeing the healthcare provider to ensure patient understands the compliance issues related to pain management care at APS.
 - A signature agreeing the self pay program will be required to proceed.

Initial Cost to patient:

- Initial visit: \$300 includes urine drug screening
 - Payment to be collect after the pre-visit interview.
- Follow up visits: \$225 including urine drug screening
 - Payment to be collect upon check in
- Misc. cost of additional services (if applicable) will be discussed with patients in advance of care.

PAYMENT DOES NOT GUARANTEE A PRESCRIPTION

Accepted Forms of Payment:

- Debit/Credit Cards
- Personal Checks
- Cashier's Check

Payment in the form of **cash, money order, or pre-loaded** debit card is **NOT** accepted.

Key factors to stay in self referral program:

- Keep all appointments as scheduled
- Illicit drug use will result in automatic discharge
- Urine drug screenings will be required as requested by provider, no questions asked
- Pill counts are mandatory as requested, failure will result in discharge at the providers discretion
